Andrew Denton



Andrew Denton is an award-winning writer, performer and producer. His TV programs include The Money or the Gun, Enough Rope, CNNNN (The Chaser), and The Gruen Transfer.

In 1997, Andrew witnessed the painful death of his father Kit. Determined to help others avoid this suffering, he campaigned to introduce compassionate laws for voluntary assisted dying. His two, ground-breaking podcast series, **Better Off Dead**, (2015 & 2021) helped to both inform, and inflame, this debate.

He formed the organisation Go Gentle Australia in 2016 to help Australians with untreatable or terminal illnesses, as well as their families and carers.

In tandem with state-based organisations, Andrew has led successful advocacy campaigns to introduce voluntary assisted dying laws in Victoria (2017), Western Australia (2019), Tasmania, South Australia and Queensland (2021), and New South Wales (2022).

Professor Ann Bonner

Head of School, School of Nursing and Midwifery, Griffith University

Prof Ann Bonner PhD, RN, has over 30 years' experience in nephrology and her research interests spans the trajectory of chronic kidney disease with a particular focus on health literacy, symptom management, self-management, health service innovation, and advanced practice nursing roles. She has attracted NHMRC research funding and has over 180 publications. Ann is a member of the Australian Institute of Health and Welfare (AIHW) Chronic Kidney Disease Expert Advisory Group, a lifemember of the Renal Society of Australasia, and in 2021 was inducted into the International Nurse Researcher Hall of Fame.



Dr Bav Manoharan

Clinical Lead, Voluntary Assisted Dying

Dr Bav Manoharan is focused on ensuring voluntary assisted dying in Queensland is high quality, safe, accessible and compassionate. Dr Manoharan was heavily involved in the Australian Medical Association Queensland (AMA Queensland) submission in response to the Voluntary Assisted Dying Bill Parliamentary Inquiry as the peak medical body's Vice President and CEO at the time.

Before becoming the Voluntary Assisted Dying Clinical Lead he was the State Clinical Director of the Queensland Health COVID-19 Vaccination Taskforce and Vaccine Command Centre. He is a wellregarded systems and strategic thinker and understands the need and benefit of strong corporate and clinical governance in complex health systems.



Professor Ben White

Professor of End-of-Life Law and Regulation, Australian Centre for Health Law Research, QUT

Ben White is a Professor of End-of-Life Law and Regulation at the Australian Centre for Health Law Research in the Faculty of Business and Law, QUT. He has been researching end-of-life law, policy and practice for over 20 years, and now focuses on voluntary assisted dying. In late 2019, he was awarded a 4-year Australian Research Council Future Fellowship entitled 'Optimal Regulation of Voluntary Assisted Dying'. Ben's work has contributed to evidence-based voluntary assisted dying law reform and implementation. Key work (with Lindy Willmott) includes their model Voluntary Assisted Dying Bill and developing the mandatory training in Victoria, Western Australia and Queensland for clinicians providing voluntary assisted dying.

Professor Liz Reymond



Deputy Director of Metro South Palliative Care Service and Director of Brisbane South Palliative Care Collaborative

Liz Reymond is Deputy Director of Metro South Palliative Care Service (MSPCS) and Director of Brisbane South Palliative Care Collaborative-the research, education and service development arm of MSPCS. Her research interests include palliative care symptom management, advance care planning, and palliative care service delivery and development. Liz is currently directing various palliative care projects at local, Queensland-wide and National levels, including the national caring@home projects; the Queensland-wide PallConsult project providing support for clinicians delivering end-of-life care in Queensland; the Statewide Office of Advance Care Planning; and more recently has become involved with the Queensland Voluntary Assisted Dying Pharmacy and Support Services.



Dr Fabian Jaramillo

General practice Liaison Officer MNHHS / Brisbane North PHN

Fabian migrated to Australia from Colombia in 2007. Since his arrival he has worked in a variety of practices throughout Queensland. He is a practicing GP in Kenmore and works as a GP Liaison Officer in Metro North.



Dr Gareth Wahl



Emergency physisican, Toxicologist, Co-Director of Emergency Medicine Training, Perth

Dr Gareth Wahl is an Emergency Physician practising in a tertiary hospital in Perth. In addition to his Emergency Department work, Gareth has been supporting people to access their preferred endof-life care (including voluntary assisted dying assessment and administration) in homes, hospitals and other care facilities across Western Australia since July 2021.



Project Coordinator, Australian Centre for Health Law Research, Faculty of Law, QUT,

Kat joined the Australian Centre for Health Law Research in 2019. She managed the Victorian voluntary assisted dying training program between 2019 and 2022. She was involved in the delivery of the voluntary assisted dying training program for Western Australia, and currently manages the development of the Queensland training. Kat also contributes to research in the area of end-of-life law. Prior to joining the Australian Centre for Health Law Research, Kat worked in business management and operations in the private sector for eight years.



Professor Michael Dooley

Director of Pharmacy, Alfred Health, Melbourne Australia

Michael is the Director of the Victorian Voluntary Assisted Dying Pharmacy Service. He has had a leadership role in the development, implementation and delivery of medication and pharmacy related aspects of voluntary assisted dying in Victoria. This includes visiting patients and practitioners as part of the team of pharmacists who provide the service.

Michael holds a joint appointment as Director of Pharmacy at Alfred Health and Professor of Clinical Pharmacy, Centre for Medicine Use and Safety at Monash University in Melbourne Australia. His is also an Adjunct Professor in the Department of Epidemiology and Preventative Medicine at Monash University.

Ms Tricia Matthias



Project Executive Director, Voluntary Assisted Dying, Queensland Health

Tricia is responsible for leading the implementation of voluntary assisted dying in Queensland.

Tricia is a highly respected policy and legislation expert. Most recently she has led the Voluntary Assisted Dying Bill 2021 debate process, and successfully managed the fast-moving development of the Chief Health Officers' Public Health Directions to assist in containing and responding to the spread of COVID-19 in Queensland.

She has extensive experience in leading teams through all stages of legislative development across more than 30 Bills, including the first Queensland laws to ban smoking in public places, criminalising the practice of conversion therapy, establishing Victims Assist Queensland and reform of TAFE Queensland.
