Terms and conditions

- 1. If successful, the nominated nurse will receive fully funded access to an APNA Corporate Membership for up to 12-months, valued at \$318, starting as early as 1 July 2024 until 30 June 2025.
- 2. The fully funded membership cannot be extended beyond 1 July 2025. This includes late applications or transferred access.
- 3. The APNA Corporate Membership is not inclusive of professional indemnity insurance, but this can be purchased separately from APNA once your new membership is activated.
- 4. Each APNA Corporate Membership allocation can only be assigned to one individual per general practice, AMS,
- 5. All continuous professional development (CPD) completed under the membership can only be recorded under the successful nurse who completed the CPD. The completed CPD cannot be transferred to another nurse.
- 6. Access to the APNA Corporate Membership can be transferred to a different nurse within the same general practice, AMS, or ACCHO in instances where staff cease employment.
- 7. Up to three nurses per practice, ACCHO, or AMS can be nominated per application. Please list your nurse nomination preferences by order (i.e. the nurse listed first in your application will be first in line to receive the membership, if successful. Should the nurse listed first cease their employment, the membership can be transferred to the nurse listed as your second preference).
 - (a) Each general practice, ACCHO, AMS who employs the successful nurse is responsible for notifying NQPHN of changes to the membership (e.g. transferring the membership when the nurse ceases employment). Please contact the NQPHN PCE team to transfer and/or update the membership.
- 8. Any incomplete or incorrectly completed nomination submissions will be ineligible.
- 9. To avoid delays in contacting successful nurses, provide a direct email address for each nominated nurses in the application form.
- 10. Only nominations for nurses working in general practice, AMSs, or ACCHOs in the NQPHN region will be accepted.
